Chairman Jerry Cooley called the meeting to order at 6:00 p.m

After a review of the February minutes (no meeting in March), Mr. McDanel made a motion for their approval. Mr. Williams seconded and the motion carried.

1. FINANCIAL REPORT: Mr. Pinto gave the financial report which was approved.

2. OLD BUSINESS:
