MEETING MINUTES 9-12-17 10 - 19 - 17

The Tri-County Airport Authority held a monthly meeting on Tuesday. September 147, 2017 at the airport terminal building. Attending were the following members:

Also in attendance was Lee Lewis, P.E. of AVCON, INC. Chairman Cooley called the meeting to order at 6:00 pm. Mr. Town was introduced as a new member of the Authority. The minutes of the August 8 meeting were reviewed and approved. The following agenda topics were also discussed:

- Financial Report: Mr. Pinto presented fuel inventories, financial information, and account
 balances in the Treasurer's Report and the Manager's Report. It was noted that the fuel inventory
 summaries were not consistent between the two reports. Mr. Pinto reviewed the methods used
 for identifying fuel inventory and indicated the data will be reviewed and corrected.
- Missing Link Parallel Taxiway: Once Ingenium has recommended release of retainage, the Authority will owe the contractor (GCUC) retainage withheld. Mr. Rich was scheduled to coordinate with the contractor the following day. He will request the Engineer's certification of completion from Ingenium and a retainage payment request from the contractor. However, the Authority is ineligible for state grant reimbursement until the 2015-16 audit is submitted and the current grant restrictions are removed by FDOT. It was noted that Ingenium was awaiting as-built and material testing documents from the contractor prior to certifying completion as the standing water in the infield was a concern.
- Box Hangar/Taxiway Project: Mr. Lewis indicated that Ingenium recently revised the geometry of the taxiway fillets per FAA comments and was completing the bid documents. The project should not be advertised for bid until the current grant restrictions are removed by FDOT. Ingenium is to provide an opinion of probable construction costs in the next two weeks. This information will be needed to ensure programmed FDOT grant funding is adequate for the construction and professional services costs.

A discussion ensued on the Authority's best interest in proceeding with bidding and construction and what respective role(s) Ingenium and AVCON will have. Options range from participation by Ingenium exclusively, AVCON exclusively, or involvement by both firms based on a well-defined

delineation of responsibilities. Ingenium will be provided an opportunity to discuss advantages to their continued management of the project through the bidding and construction phases during or prior to the October Board meeting. The Board may then consider a decision on the best course of action to proceed for bidding and construction.

It was also noted that the hangar manufacturer consulted for the project indicated that they cannot provide structural design for the hangar foundation and it was discussed a proposal for structural design may be needed. In the event the approved Ingenium design scope did not include structural design, then a structural design proposal may be warranted. This issue will be discussed in next month's meeting.

- Rex Lumber Hangar: This project is on hold pending further information from the tenant.
- Flooding Along Taxiway, Pond & Building: AVCON will provide a proposal for a Stormwater Master Plan to explore a comprehensive solution for addressing airport stormwater. Available funding in the current year grant will be determined based on the estimated costs of the box hangar/taxiway project. Mr. Lewis indicated that the scope of the Stormwater Master Plan can be scaled (i.e. Phase I versus Phase 2, etc.) depending on the available funds. The project can begin this fiscal year as soon as the work program is updated, the current grant restrictions are removed by FDOT and the FDOT grant is issued. Chairman Cooley noted a small diameter outfall pipe beneath the runway was collapsed; however, it was agreed the pipe replacement should be postponed until the Stormwater Master Plan can identify the recommended future drainage improvements (i.e. pipe size, location, etc.) required.
- Annual Audit: The draft audit was submitted for Authority review and response to findings. Mr. Lewis noted that due to the current restrictions on state funding, the audit submittal is the Authority's highest priority. Following a review of the audit findings and proposed Authority actions to improve financial controls through third-party training, Chairman Cooley signed prepared responses provided by AVCON and Mr. Lewis will coordinate those with the audit accountant. The final audit will be coordinated with the FDOT Comptroller as well as the Department of Economic Opportunity who administers special districts. AVCON will coordinate with the accounting firm to ensure a timely start on the 2016-17 annual audit which is due no later than June 30, 2018.
- Financial Administration Support: Mr. Town will coordinate with a local accounting firm to
 provide training with improved processes. A part-time airport employee may also be considered
 if required to address the financial reporting and reconciliation items identified in the audit.
- Five-Year FDOT Work Program: Mr. Lewis provided a summary of the current FDOT funding plan over the next five years as well as several recommended revisions to the plan. Primary revisions included redistributing future funds within the respective year to address the Stormwater Master Plan, the 10% match to federal dollars for the Airport Layout Plan, acquisition of a new maintenance vehicle, corporate hangar development, and tree clearing. Mr. Locke suggested that fence improvements be added to the tree clearing project description. Other potential airport improvements, including replacement of airfield lighting with LEDs and the replacement of an existing hangar, were discussed but will be deferred at this time.

 Announcements: The Authority Board meeting is re-scheduled to Thursday, October 19, 2017 at 6:00 pm. Following that meeting, future meetings will resume on the normally scheduled second Tuesday of each month.

The meeting was adjourned at 8:45 pm.
